MESSAGES WILL BE ALLOWED TO EXPIRE AT 11:59PM

- Message 1's will be allowed to expire at 11:59pm as the threat for heavy rainfall has come to an end.
- Storm activity has decreased over the District with a slight chance for any additional showers through the overnight hours. Any additional showers will favor eastern areas of the District, however the chance for additional storm activity will taper off drastically after midnight.
- Lows tonight will fall into the low to mid 60's on the plains under mostly cloudy to partly clear skies.

STORM RAINFALL POTENTIAL AND DURATION: A light shower or thunderstorm will produce a trace to 0.10" in 10-30 minutes.

WORST CASE SCENARIO: An unlikely slower moving shower or thunderstorm will produce 0.10-0.30" in 60 minutes.
